Postpartum Instructions

After Your Child's Birth

- 1. Begin charting immediately after your lochia (postpartum bleeding) decreases (usually around 3 weeks postpartum).
- 2. Read through chapters 4-8 in the user manual to brush up on charting and observing basics. There is also postpartum information that starts on page 61.
- 3. If you are totally breastfeeding, the first 56 days after birth are infertile. Totally breastfeeding means your baby gets a bottle only rarely all nutrition needs to come from the breast. After those 56 days, you may have to avoid genital contact for 1-2 weeks to establish your basic charting pattern. Check with Lori if you are unsure.
- 4. If you are partially breastfeeding, or if you are not breastfeeding, avoid genital contact for one month after you begin charting.
- 5. The end of the day (when the woman goes to bed) on a day that gets a plain green stamp is considered infertile.
- 6. The end-of -day instructions continue through your first normal menstrual cycle (this may or may not be the first menses after birth sometimes postpartum cycles are not normal for a little while).
- 7. When in doubt, consider yourself at peak fertility and do a count of 3.

All follow-up visits will be held via Zoom until further notice.

1st follow up 5 weeks postpartum

2nd follow up 7 weeks 3rd follow up 9 weeks 4th follow up 11 weeks

5th and up Every 6 weeks through 3 complete normal menstrual cycles

The follow-up schedule is flexible and is adjusted to meet individual needs.

Additional Instructions

- 1. Schedule your first postpartum follow up for about 5 weeks postpartum, or when you have about 2 weeks of charting complete.
- 2. Bring your chart to each follow-up. If meeting via Zoom, send a picture of your chart the day of the appointment. You can e-mail or text the picture. A scanned document is also fine.
- 3. Bring a form of payment to your first follow-up to pay for the appointment and any materials. Cash, check, credit card, PayPal, and Venmo are all acceptable if we meet in person. If we are meeting via Zoom, please use PayPal at paypal.me/loriharlan or Venmo (loriagnes).
